



VDH Products B.V. Privacy Statement

In this privacy statement, VDH Products B.V., having its registered office at Productieweg 1, Roden (9301 ZS), Chamber of Commerce registration number 04036720 (hereinafter referred to as VDH Products), describes which personal data VDH Products gathers and processes, the reasons for processing this data, and its cookie policy.

General

VDH Products respects the privacy of all visitors to its website <https://www.vdhproducts.nl>, its (potential) customers and (potential) business relations. VDH Products therefore treats your personal data with the utmost of care. This data will not be sold, traded or shared with parties that are not associated with VDH Products' services. In all cases, VDH Products observes the requirements set by the Dutch data protection legislation.

Processing of personal data

VDH Products records the data you provide within the context of VDH Products' service or when you contact VDH Products by other means (e.g. by email or via the contact form on VDH Products' website). VDH Products only stores and processes personal data that you provide. You can visit the VDH Products' website anonymously at any time; in other words, without sharing any personal data with VDH Products.

Objectives

VDH Products uses your data to optimise its service, including undertaking activities aimed at increasing its customer database and for marketing purposes. Your data will only be used for the purpose for which you provided the data. Your data will not, in principle, be disclosed to third parties without your express permission. This only happens if it is necessary in the context of VDH Products' service or if it is legally required.

Retention period

Your personal data will be stored for as long as VDH Products deems necessary in terms of the nature of the contact. This data will never be stored for longer than necessary, unless this is required in relation to other legislation.

Newsletter

VDH Products informs interested parties of its service by way of a newsletter. Each newsletter contains an unsubscribe link. The newsletter subscriber database will not be disclosed to third parties. V

Security

VDH Products takes appropriate technical and organisational measures to prevent loss or improper processing of personal data. These measures include the following:

- the website of VDH Products is protected using an SSL certificate. This means that confidential information, for example information provided via a contact form, is encrypted during transmission;
- access to electronic systems is password protected; and

- only authorised members of staff/third parties have access to your personal data. These measures are there to provide an appropriate level of security.

Cookies

VDH Products makes very limited use of cookies. Cookies are small files containing data that are stored on the hard drive of your computer, tablet or smartphone.

VDH Products uses Google Analytics. Google Analytics may therefore install cookies to gather data with the ultimate aim of optimising your user experience. Gathering data via Google Analytics gives VDH Products an insight into usage, and these statistics may be used on its website. The information obtained is transferred to Google, which stores it on servers in the United States. Google can provide this information to third parties if Google is required to do so by law, or if these third parties process the information on behalf of Google. VDH Products has no influence upon this. VDH Products has not given Google permission to use the analytics information obtained for other Google services. Third parties have no access to the cookies installed by VDH Products. If you wish, you can change the settings of your browser to refuse cookies. Switching off cookies only affects the computer and browser on which you perform this action. If you use multiple computers and/or browsers you should repeat this action as often as is necessary.
